HARTA will be looking a replacement for VP Leduc for the 2025-26 program year.

The budget for the 2025-26 program year will fund the luncheons in Leduc and Wetaskiwin as well as the mini-conference. The budget also includes three executive meetings. (Two of these are included with the Leduc Luncheons in

# Is Your HARTA Membership Up-To-Date?

In late November of each year, HARTA receives a subsidy cheque from ARTA, based on the number of paid up ARTA members that are also Alberta retired teachers with 5 years or more of teaching experience for a board in Alberta as well as being a HARTA member as of September 1st of that year. Each branch president is required to send their list of current members to the ARTA office. HARTA's yearly subsidy is based on the number of paid up ARTA members who are retired Alberta teachers who are eligible for an Alberta teachers' pension and who are members of HAR-TA. If your membership is due for renewal, you can renew it at a regular HARTA meeting, by sending an e-transfer to: rnthompson@shaw.ca, or by a cheque, or money order payable to HARTA, care of

HARTA, 4020 - 37th Avenue, Leduc, Alberta T9E 6C9. (During the mail strike please phone the president to work out possible work-arounds for getting a check to HARTA. My phone number is (780) 986-8349. Please leave a voice mail message on my phone.) Please make out the cheque, money order, or e-transfer for \$10.00 for each year you would like to renew. If you are 80 years of age or older and your HARTA membership is paid up, you are considered a lifetime member. You no longer need to pay membership fees. Please let us know when you celebrate your 80th birthday so we can change your membership status. Please also confirm your ARTA status with ARTA. (if you have an ARTA Benefit Plan, you do not need to verify your membership. Your yearly membership fee is included in your ARTA Plan.)

### **Confusing Abbreviations**

After you retired from teaching you probably noticed a number of abbreviations re: retirement. ASEBP (Alberta School Employee Benefits Plan) refers to the health benefits provided by various school districts. The ARTA (Alberta Retired Teachers' Association) Plans, are plans available to all ARTA members and Associate Members. The ATRF (Alberta Teachers' Retirement Fund) is the fund that pays teachers' pensions to retired Alberta teachers. Retired teachers with concerns re: their pensions, should contact the ATRF re: these issues. CPP (Canada Pension Plan) refers to the Pension Plan provided by the Canadian Government. The OAS (Old Age Security) is a supplementary payment to every person over 65 years also created by the Canadian Government. As a review of these abbreviations, I have listed all these abbreviations with their

websites where you can get more information on a given topic. The ARTCF (Alberta Retired Teachers' Charitable Foundation) is ARTA's foundation to support various partners with their various projects to achieve their goals. AIMCo (Alberta Investment Management Corporation) is the Alberta Government's umbrella Investment Organization which also manages various Government Pensions)

On Thursday, September 11, Linda and I attended the Second Wind Conference at the Chateau Louis Conference Centre in Edmonton. I have inserted some information gleaned from the conference for the information of HARTA's membership. The Keynote started the conference. Below please find a short bio of the speaker and a brief description of some of her comments re: aging well.

### **Keynote Details**

Aging Well in the Fourth Industrial Revolution

#### Presented by Dr. Lili Liu, PhD



Lili Liu is a professor in the School of Public Health Sciences and dean of the Faculty of Health at the University of Waterloo. She maintains an externally funded research program that focuses on

acceptance and adoption of technologies by older adults, their care partners and health care professionals.

As an occupational therapist, Dr. Liu engages with community organizations, as well as policy and decision makers. Alzheimer Societies, police services; search and rescue, dementia advocacy and caregiver associations, nationally and internationally, are partners in her research program.

As an AGE-WELL network investigator, Dr. Liu's current research program examines the applications of technologies and other innovations to mitigate risks of going missing among persons living with dementia. AGE-WELL is Canada's technology and ageing network, a federally funded Networks of Centres of Excellence (NCE) program, aiming to accelerate the delivery of technology-based solutions for older adults and caregivers (https://agewell-nce.ca.)
