ARTA Benefits Updates

If you subscribe to the ARTA Benefits Plan, be aware there are several updates which have been approved by the ARTA Board of Directors and will take effect November 1, 2018. A few to note are:

- Increases in maximums in several areas
- Limit of 1000 diabetic test strips a year
- Added coverage for nebulizers
- Coverage for ankylosing spondylitis and psoriatic arthritis managed under Enhanced Specialization process
- Fluoride varnish treatment eligible
- Shringrix covered
- ARTACares is a new program to help you address your or a loved one's health issues.

Notes to Snowbird Benefits Plan Members

- You are now able to submit your request for a greater than 100 day supply of drugs directly to your pharmacist without any additional paperwork.
- Plan members are reminded that each person returning to Canada to renew their 92 day absence trip duration MUST:
 - Return to their home province
 - Have "proof" of the date of return. If you are part of a couple, you each need your own receipts.
- Excluded from travel coverage are "Any cardiac catheterization, angioplasty, or cardiovascular surgery unless approved in advance by Allianz Global Assistance" We were assured that in a real emergency this would not apply. It seems that certain hospitals particularly in the US tend to pile on procedures that are not immediately necessary.

A story related to immigration

In the early 1970s a local Alberta superintendent decided that he wanted a different summer break. He volunteered to go to Jamaica to help build houses for the local people. He paid his own expenses. When he returned he asked whether my Grade 12 Social Studies class would be interested in a slide presentation he had made on his trip. His presentation took the whole period as he explained what he had seen and done. He stayed to talk to me after class. He was greatly disturbed by what he had experienced on his first trip abroad. He described the way of life of the people and commented on the poverty he had experienced. He described the countryside and the orange ponds that he had seen polluted by the aluminum plants. He lamented the exploitation of the land and the people suggesting that he could see the time when those people would look at Canada, see how well by comparison we lived and decide that they wanted to live the same way. They would simply come north to settle. His story now fits the current march into Mexico of hundreds of people from Guatemala and Honduras heading for the U.S. border. Europe has experienced similar migrations from Africa and the Middle East promoted no doubt by the "glamorous" images seen on television and in the movies and by the lure of wealth and safety. Is it really so surprising?

U.S.President and elephants

Earlier this year U.S. President Donald Trump reversed a ban made by his predecessor on importing remains of African elephants killed by trophy hunters.
