

## STARTA BUSINESS:

#### Greetings from your STARTA Executive:

Your STARTA executive hopes you are well and able to enjoy the last of our summer/fall weather. We have been doing some serious thinking about how STARTA can proceed during this challenging time. As you might recall, in April your executive asked for a vote via text or email regarding a motion made by two members to postpone the scheduled May 7, 2020 AGM until the fall. The vote was highly in favor, and the motion passed. So now we are at fall, and our 'Covid' situation has not improved. The executive met informally over Zoom on September 8 and after a good deal of discussion, decided to proceed with both executive meetings and possibly an AGM by Zoom. To this end, we purchased a \$200 Zoom license which allows us unlimited time for one year for up to 100 people. At a more formal Executive meeting on September 15, we passed a motion to hold a virtual AGM rather than an in-person meeting. We felt that it was necessary to close off last year's business and elect a new executive. There were several reasons for selecting the virtual meeting:

- 1. The probability of an increased number of Covid-19 cases this fall is great. None of us can see the future. There is a good chance that even if we set a date, we might have to cancel.
- 2. Our age group is the most vulnerable. We would hate to be responsible for any spread of Covid-19.
- 3. There are liability concerns regarding possible Covid-19 spread due to a meeting we have initiated. ARTA is exploring the legal side of holding inperson meetings, but it is likely that the insurance ARTA holds on our behalf would not cover a possible lawsuit due to a Covid-19 issue.

Everyone will receive a package, by email (or regular mail if email is not available) by the end of September. That package will include reports and instructions for the STARTA Annual General Meeting which is scheduled for October 23, 2020 at 10 am. You will be contacted by your STARTA "phoner", to determine if you wish to be part of this meeting.

There is an ongoing discussion as to whether or not virtual meetings are a "legal" way to do business. Our constitution is not clear on this subject; nonetheless, the executive agreed that they are the safest way to proceed at this time.

We have no way of knowing who is a voting member of STARTA. Our constitution tells us the following:

### Article II - Membership

A. Voting Membership

STARTA will accept into membership, with full voting power, any person in receipt of a pension from The Alberta Teachers' Retirement Fund.

STARTA membership shall be principally persons resident in or previously employed within the geographic area encompassed by the City of St. Albert, the County of Barrhead, the County of Sturgeon and the Municipal District of Westlock.

B. Associate Membership

The following persons may be accepted as Associate Members without the right to vote or hold the office of President, Vice President, or Branch Benefits Representative ARTA Representative:

- 1. The spouse of a member.
- 2. Retired teachers from other educational institutions in Alberta.
- 3. Retired teachers in receipt of a pension from other provinces.
- 4. Honorary Members of the Alberta Teachers' Association.
- 5. Other persons as approved by the Executive. \*

5.\*We have accepted members of ARTA who are not from the Education Sector as associates.

Please let voting members have the first shot at joining us as there is a limit to the number of participants. If you'd like to be an observer, let your phoner know so you can be sent an invitation if space is available.

We are considering holding a practice Zoom session before the meeting if asked. Meanwhile, here is a video, passed along by VP Mary which I found to be excellent.
