Potential Group trip to NYC and Washington DC September 15-24, 2023

Are you interested in a ten-day group trip to NYC and Washington DC?

If we get 16 people signed up and deposits (\$1000) paid directly to <u>https://www.ststours.ca/</u>, which are refundable until the trip is confirmed, then the trip will go ahead.

Laurie Mitchell, a retired teacher from Lethbridge and former leader of many group trips to England, Scotland, France, Italy and NYC will be your point person and help to orchestrate payment schedules, insurance if needed and fine tune the agenda.

The group will fly out of Calgary on September 15 spend five days in NYC enjoying two Broadway shows TBD, tours of One World, Statue of Liberty, the Met Museum, Radio City Music Hall, Greenwich walking Food tour – so yummy and informative and more. We then travel by train or private coach September 20 depending on numbers, to DC for our remaining days, which will include a Hop-on-Hop-off Bus tour, Capitol Hill, Mount Vernon, Alexandria and more. 

Mary D'Andrea

Mary D'Andrea passed away at Ste. Therese Villa in Lethbridge on November 27, 2022 at the age of 86. A long-time SWARTA member, Mary received her early education in southern Alberta, beginning her teacher training at the University of Calgary. Her teaching career took her from schools in Readymade, Picture Butte, and Etzikom before settling in Fort Macleod where she divided her time between raising her family, substitute teaching, and taking night classes culminating in her receiving her BEd in 1979. After twenty years of teaching upper elementary grades in Willow Creek School Division, Mary retired in 1991. She was involved in a number of organizations and service clubs including the Lions, C.W.L. and the Italian Canadian Club.

Mary is survived by her three children, seven grandchildren and five great-grandchildren as well as three sisters and a brother. She was predeceased by her husband Mike.



David Lynagh

David Lynagh passed away in Lethbridge on December 8, 2022 at the age of 83 years. He was born in Banbridge, Northern Ireland. David taught in Zambia before coming to Canada in 1968, first to Wildwood AB and later to Lethbridge where he taught in both the public and Catholic school districts, completing his career as the Religious Education Consultant for the Lethbridge Catholic District.

As a teacher, David was an ardent supporter of the ATA and after his retirement he transferred that same energy to SWARTA and ARTA. Among his contributions locally he served as Holy Spirit representative in 2003, moved to Vice-President in 2004, President from 2005 to 2007, Past-President from 2007 to 2011 and as "Sunshine Person" from 2008 until his decision to step down from the Board in 2017. Provincially, he was a frequent SWARTA representative to the ARTA AGM and served on the committee which led to the establishment of the ARTA Trust Fund. In 2007 David served on ARTA's ad hoc Political Action Committee related to the unfunded pension liability and which identified issues that might require political action on the part of ARTA.

David is survived by his wife Eileen, a daughter, two sons, and six grandchildren as well as two sisters and a brother.
